

**“\$5K More May’s to Win” Promotion  
Goldsby Gaming Center**

**Official Rules**

- 1) Goldsby Gaming Center is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Goldsby Gaming Center is giving away up to \$5,000 in cash and Prizes on Saturdays in May 2019.
- 2) Patrons must be 18 years of age or older with a valid photo I.D and must be a Goldsby Gaming Center Player’s Club card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Goldsby Gaming Center; employee of the Nation prohibited from participating as set forth by any of the Nation’s policies; regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
- 3) Beginning Sunday, April 28, 2019 at 8:00 a.m. through 11:00 p.m. on Saturday, May 25, 2019 all Patrons who have a Goldsby Gaming Center Player’s Club card will be eligible to earn entries for drawings in the following ways:
  - a) Patrons will earn one (1) entry for every three (3) points earned on their Goldsby Gaming Center Player’s Club card. Partial entries will not carry over once drawings begin.
  - b) Patrons will earn entries at 3X the rate on Mondays, April 29, and May 6, 13, and 20, 2019, and Tuesdays, April 30, and May 7, 14, and 21, 2019.
  - c) New Members may earn one (1) free entry into the drawing by signing up for a Goldsby Gaming Center Player’s Club card.
- 4) On Saturdays, May 4, 11, and 18, 2019 a total of \$1,000 in cash will be given away in the denominations of six (6) \$50, two (2) \$100, two (2) \$150, and one (1) \$200 each night in random drawings between 6:00pm and 11:00pm.
  - a) Patrons are responsible for activating their entries by properly inserting and removing their Goldsby Gaming Center Players Club card into an electronic gaming machine within thirty (30) minutes of each drawing time. Patrons must activate their entries to be eligible to win.
  - b) One (1) winner will be chosen every thirty (30) minutes.
  - c) Patrons may only win once per drawing date.
  - d) Patrons must be present to win. Winner(s) will be announced and given three (3) minutes to respond to the promotional area. In the event of a “No Show” another winner will be drawn.
- 5) On Saturday, May 25, 2019 a total of \$800 in cash will be given away in the denominations of six (6) \$50, two (2) \$100, and two (2) \$150 in random drawings between 6:00 p.m. and 10:30 p.m. At 11:00 p.m. we will draw one lucky winner to win a grand prize package which will consist of one (1) Oklahoma Joes Smoker and Grill (valued at \$489.99), one (1) Yeti Tundra 65 (valued at \$349.99), and one (1) \$200 gift card to Wheelers Meat Market.
  - a) Goldsby Gaming Center’s casino management system will be the sole determinant of each winner.
- 6) Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/ or a 1099 tax form, when applicable provided by the Chickasaw Nation.
- 7) Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
- 8) Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/ or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
- 9) Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
- 10) Participation in this promotion and/ or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
