

**“Lucky 7’s”
Goldsby Gaming Center**

Official Rules

1. Goldbsy Gaming Center is a governmental enterprise of The Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Goldbsy Gaming Center is giving away a \$350 every Thursday during the months of April, May and June. For Goldsby’s “Lucky 7’s” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D with complete and accurate information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Goldsby Gaming Center; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Patrons participating in bingo on Thursday’s in April, May and June will be eligible to participate in our manual hopper drawing during regular session bingo.
 - a.) Patrons are responsible for legibly filling out the promotional ticket and placing it into the hopper with their name and phone number listed.
 - b.) Patrons who purchase a bingo pack will receive a voucher each Thursday to participate in our manual hopper drawings.
 - c.) One voucher per person per day.
 - d.) The hopper will close at each specific drawing time.
 - e.) Drawings will occur during regular session bingo where a total of seven (7) winners will be drawn on Thursday’s in April, May and June
 - f.) Each of the seven (7) Patrons will win a share of \$350.
 - g.) Patrons must be present to win.
 - h.) Drawing hopper will be emptied after the conclusion of the drawings each Thursday.
 - i.) Limit of one (1) prize per Patron per night during this promotion.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each patron to the exclusive jurisdiction of the Nation, its

regulatory bodies and courts without limit to time or event, which shall govern this promotion.
